**The Wallaby Tales Traveling Zoo** will be there to display and delight children of all ages.

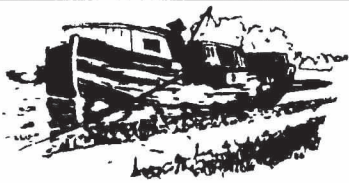
**Ethnic delicacies** will delight the palette and beautiful **hand made Crafts and Jewelry** will be available for purchase.
