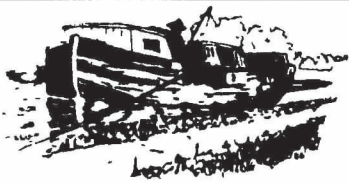
Ramsey Outdoors will provide kayaks for a **free paddle day** along the Morris Canal.
